RESOLUTION AUTHORIZING AND APPROVING A PAYMENT IN THE AMOUNT OF TWENTY-FIVE THOUSAND AND 00/100 (\$25,000.00) DOLLARS TO THE HUDSON VALLEY AGRIBUSINESS DEVELOPMENT CORPORATION ("HVADC")

WHEREAS, pursuant to Sections 402 and 1411 of the Not-For-Profit Corporation Law of the State of New York, SCFC was established for certain charitable and public purposes including, among other things, relieving and reducing unemployment, promoting and providing for additional and maximum employment, bettering and maintaining job opportunities, instructing or training individuals to improve or develop their capabilities for such jobs, carrying on scientific research for the purpose of aiding a community or geographical area by attracting new industry to the

community or area or by encouraging the development of, or retention of, an industry in the community or area, and lessening the burdens of government and acting in the public interest; and

WHEREAS, by resolution #13-11, dated June 14, 2011, the Agency was approved to pay HVADC \$25,000.00 Dollars to HVADC and to earmark \$50,000.00 from the Millennium Grant proceeds to pay \$25,000.00 to HVADC on or about July 1, 2012 and \$25,000.00 on or about July 1, 2013; and

WHEREAS, by resolution #29-11, dated December 13, 2011, the Agency transferred its Millennium Revolving Loan Fund ("MRLF") to SCFC; and

WHEREAS, by resolution #2-12, dated February 14, 2012, Agency transferred the responsibility of funding and overseeing the contract with HVADC to SCFC; and

WHEREAS, by resolution #02-13, dated June 11, 2013, SCFC made a payment to HVADC in the amount of Twenty-Five Thousand and 00/100 (\$25,000.00) Dollars to be made on or before July 1, 2013; and

WHEREAS, SCFC wishes to authorize a payment to HVADC in the amount of Twenty-Five Thousand and 00/100 (\$25,000.00) Dollars to be made on or before July 1, 2016.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF SCFC AS FOLLOWS:

SCFC hereby authorized a payment in the amount of Twenty-Five Thousand and 00/100 (\$25,000.00) Dollars to HVADC, to be made on or before July 1, 2016.
